The table below gives details of the works which are in progress and are planned to be delivered at Netherton Grange. The works are also shown on the plan below.

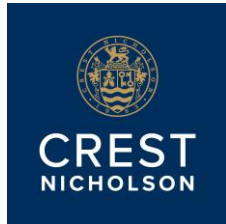
The timescales provided for completion of works are indicative and may be subject to change based on external market factors.

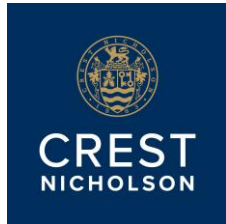
