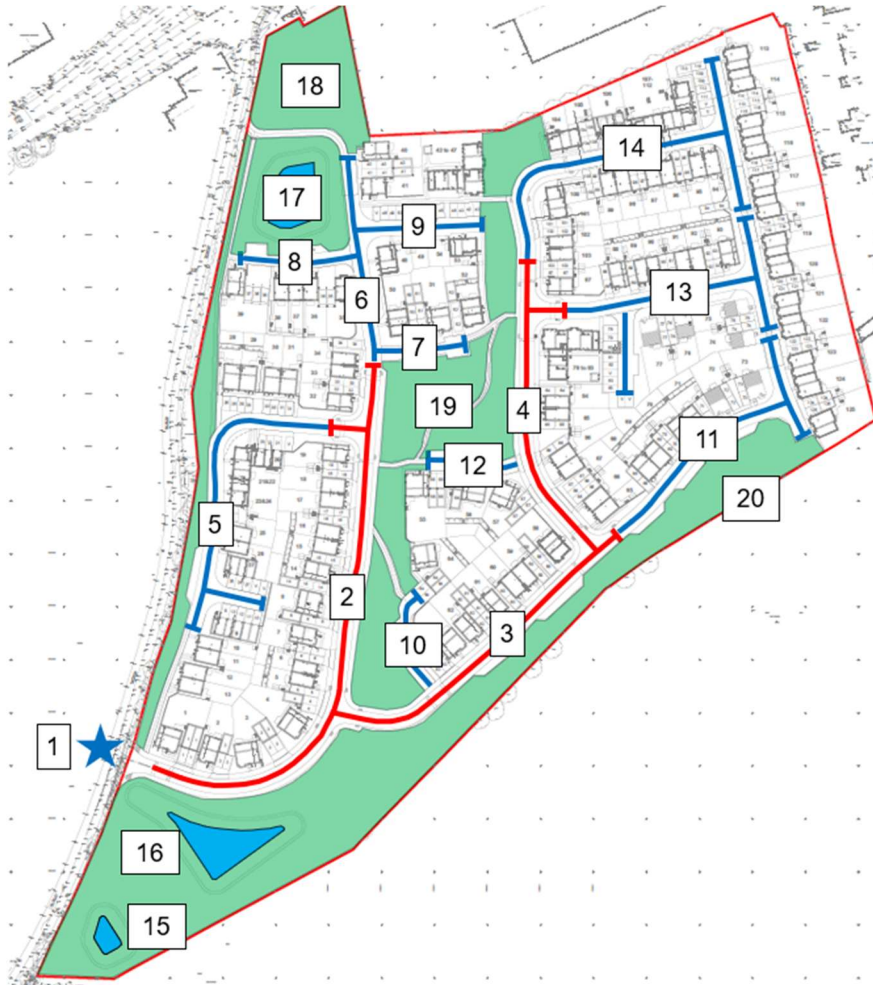
Notes:
